Background/Discussion

Generally, members of the City Council are required by State Statute to certify the results of the Municipal Election to the Ramsey County Auditor within three (3) to ten (10) days after the general election. This year, however, due to the consent decree that extended the deadline regarding mail ballots received through the mail up to seven (7) days following Election Day, canvassing the results must occur no later than Friday, November 13.
