FIELD DIRECTIONS

Charles Perry Park (Arden Hills) – 3700 New Brighton Road, Arden Hills, 55112

Take 35W to the County Road E2 exit. Head East on County Road E2. Turn right on New Brighton Road. The park is approximately 1 ½ blocks down on the park left.

Shamrock Park (Shoreview) – 5623 Snelling Avenue (County Road I at Snelling Avenue)

35W North to County Road I, go east 1 Mile to Snelling Avenue, go North 1 block. Park is on the left.
